On-line Assignment Confirmation now available from NYAIP Website at www.aipso.com/ny

In our continuing efforts to improve information access to our customers, we have upgraded our assignment information confirmation facility to an on-line facility.

This feature replaces the toll free VRU and provides a means to confirm if an assignment was generated for an individual or vehicle through the New York Automobile Insurance Plan. As with the VRU, users must enter the driver license number or the VIN (vehicle Identification Number). A reason for the request is also required. If a match is found, the facility will provide the name of the carrier the user can contact for more information.

Users will be required to complete a one-time registration and select a password to access the facility. A link to this page is now available on our PASS website for at www.nypass.com under "Plan News" and on our NYAIP website at www.aipso.com/ny under "What's New" and under "General Information". When you reach the Account Login screen, select "Register", then enter your information to complete the registration. Once you are registered, you will only need to Login for access.
